IDEABLADE END USER LICENSE AGREEMENT

PLEASE READ THIS END USER LICENSE AGREEMENT (THIS "AGREEMENT") CAREFULLY BEFORE ATTEMPTING TO DOWNLOAD OR USE ANY SOFTWARE, DOCUMENTATION, OR OTHER MATERIALS MADE AVAILABLE THROUGH THIS WEBSITE (COLLECTIVELY, THE "SOFTWARE"). THIS AGREEMENT CONSTITUTES A LEGALLY BINDING AGREEMENT BETWEEN YOU OR THE COMPANY WHICH YOU REPRESENT ("LICENSEE" OR "YOU") AND IDEABLADE, INC. ("IDEABLADE"). BY PURCHASING, DOWNLOADING, INSTALLING OR OTHERWISE USING THE SOFTWARE, YOU ACKNOWLEDGE THAT (1) YOU HAVE READ AND UNDERSTAND THIS AGREEMENT, (2) YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT, AND (3) TO THE EXTENT YOU ARE ENTERING INTO THIS AGREEMENT ON BEHALF OF A COMPANY, YOU HAVE THE POWER AND AUTHORITY TO BIND THAT COMPANY TO THIS AGREEMENT.

1. <u>Software License</u>. Subject to Your compliance with the terms and conditions of this Agreement, IdeaBlade hereby grants to You a revocable, limited, non–exclusive, non–transferable license (the "License") to access and use the Software and any updates, upgrades, modifications and error corrections provided to You by IdeaBlade, solely for purposes of either a Trial License pursuant to Section 1.1 or a Developer License pursuant to Section 1.2 if You purchased the Software. You are not licensed to and will not modify, distribute, sublicense, rent or make the functionality of the Software available to multiple users by any means, including, but not limited to, by uploading the Software to a network or file-sharing service or through any hosting, application services provider, service bureau, software-as-a-service (SaaS) or any other type of services. You acknowledge and agree that portions of the Software, including but not limited to the source code and the specific design and structure of individual modules or programs, constitute or contain trade secrets of IdeaBlade and its licensors. Accordingly, You agree not to disassemble, decompile or reverse engineer the Software, in whole or in part, or permit or authorize a third party to do so, except to the extent such activities are expressly permitted by law notwithstanding this prohibition.

1.1 Trial License.

- 1.1.1 <u>License Grant</u>. If You select the free Trial License, You are authorized to install and use the Software for the sole purpose of evaluating its functionality and performance. You may not integrate the Software into end products or use it for any commercial, productive or training purposes. You may not redistribute the Software or any part thereof.
- 1.1.2 <u>Support</u>. As part of Your Trial License You are entitled to enter three (3) support requests via IdeaBlade's support system. We will use reasonable efforts to respond to such requests within seventy-two (72) hours (excluding Saturdays, Sundays, and holidays).

EXCEPT AS OTHERWISE PROVIDED HEREIN, THE TRIAL VERSION OF THE SOFTWARE IS LICENSED 'AS IS'. YOU BEAR THE RISK OF USING THE SOFTWARE. IDEABLADE DISCLAIMS ALL WARRANTIES, EXPRESS AND IMPLIED, INCLUDING IMPLIED WARRANTIES OF TITLE, MERCHANTABILITY, FITNESS FOR A PARTICLUAR PURPOSE AND NON-INFRINGMENT AND ANY WARRANTIES ARISING OUT OF THE COURSE OF DEALING OR USAGE OF TRADE.

1.2 <u>License Grant for Use in Development</u>.

1.2.1 <u>Developer License Grant</u>. If You purchase a Developer License, Your Licensed Developers may use the Software in the development of Your Integrated Products.

For purposes of this Section 1.2:

"Your Integrated Products" are limited to those software applications that: (i) are developed by Your Licensed Developers; (ii) add substantial functionality beyond the functionality provided by the incorporated components of the Software; and (iii) are not commercial alternatives for, or competitive in the marketplace with, the Software or any components of the Software.

"Licensed Developers" are Your employees or contractors authorized by You to use the Software to develop software specifically for You. At any given time, the number of Licensed Developers cannot exceed the number of seats that You have purchased from IdeaBlade and for which you have paid IdeaBlade all applicable License Fees pursuant to this Agreement. The Software is in "use" on a computer when it is loaded into temporary memory (i.e. RAM) or installed into permanent memory (e.g. hard disk or other storage device). Your Licensed Developers may install the Software on multiple machines, so long as the Software is not being used at any given time by more Licensed Developers than You have purchased seats for.

- 1.2.2 <u>Support</u>. The standard support package entitles you to enter ten (10) support requests via IdeaBlade's support system with a 48 hour response time. The priority support package entitles you to enter twenty (20) support requests via IdeaBlade's support system with a 24 hour response time. (Saturdays, Sundays, and holidays are excluded from response times.) In no event will IdeaBlade provide support of any kind to end-users of Your Integrated Products.
- 1.2.3 <u>Updates</u>. For one (1) year from the date on which you purchase the License for the Software, You will be eligible to receive all major updates and minor updates for the version of the Software that you license. Updates replace and/or supplement (and may disable) prior versions of the Software. You may use the resulting updated Software only in accordance with the terms of this Agreement.
- 1.2.4 <u>License Options for Redistribution</u>. If you have purchased a Developer License, You may distribute the Programs as embedded in Your Integrated Products to Your end-users in object code form only pursuant to an end-user license that meets the requirements of this Section. You will not distribute the Software pursuant to this Section: (i) in any format other than in object form; (ii) as a standalone product; or (iii) as a part of any product other than Your Integrated Product. You will not distribute files used for design time integration with Visual Studio. Your end-user license agreement must: (a) impose the limitations set forth in this paragraph on Your end-users; (b) prohibit distribution of the Software by your end-users; (c) limit the liability of Your licensors or suppliers to the maximum extent permitted by applicable law; and (d) prohibit any attempt to disassemble, decompile or "unlock", decode or otherwise reverse translate or engineer, or attempt in any manner to reconstruct or discover any source code or underlying algorithms of the Software.
- 2. <u>No Trademark License</u>. You may not use the IdeaBlade product names, logos or trademarks to market Your Integrated Product.
- 3. <u>Delivery</u>. IdeaBlade will make a master copy of the Software available for download by Licensee in electronic files only.
- 4. <u>Term and Termination</u>. This Agreement and the License granted hereunder shall continue until terminated in accordance with this Section. IdeaBlade may terminate this Agreement and the License granted hereunder immediately if You breach any of the material terms of this Agreement and You fail to cure such material breach within thirty (30) days of receipt of notice from IdeaBlade. Upon termination of this Agreement, all Licenses granted to You hereunder shall terminate automatically and You shall immediately cease use and distribution of the Software; provided, however, that any sublicenses granted to Your Authorized End-Users in accordance with Section 1.2.4 shall survive such termination. Sections 4, 6, 8, 9, 10 and 12 shall also survive any termination or expiration of this Agreement. Upon termination of this Agreement, You will

- destroy (i) all copies of the Software not integrated into a live, functioning instance(s) of Your Integrated Product(s) already installed, implemented and deployed for your Authorized End-User(s), and (ii) any product and company logos provided by IdeaBlade in connection with this Agreement.
- 5. <u>Product Discontinuance</u>. IdeaBlade reserves the right to discontinue the Software or any component of the Software, whether offered as a standalone product or solely as a component, at any time. However, IdeaBlade is obligated to provide support in accordance with the terms set forth in this Agreement for all discontinued Software or components for a period of one (1) year after the date of discontinuance.
- 6. <u>Intellectual Property</u>. All title and ownership rights in and to the Software (including but not limited to any images, photographs, animations, video, audio, music, text embedded in the Software), the intellectual property embodied in the Software, and any trademarks or service marks of IdeaBlade that are used in connection with the Software are and shall at all times remain exclusively owned by IdeaBlade and its licensors.
- 7. Limited Warranty. If you purchased a Developer License, IdeaBlade warrants solely to You that the Software will perform substantially in accordance with the accompanying written documentation for the Software for a period of ninety (90) days after the date of purchase. IdeaBlade does not warrant the use of the Software will be uninterrupted or error free at all times and in all circumstances, nor that program errors will be corrected. This limited warranty shall not apply to any error or failure resulting from (i) machine error, (ii) Your failure to follow operating instructions, (iii) negligence or accident, (iv) combination of the Software with any products or software not provided by IdeaBlade or (v) modifications to the Software by any person or entity other than IdeaBlade. In the event of a breach of warranty, Your sole and exclusive remedy and IdeaBlade's sole and exclusive obligation, is repair of all or any portion of the Software, or, at its option, refund the paid purchase price for the defective Software only. This limited warranty is only valid if IdeaBlade receives written notice of breach of warranty within the warranty period. EXCEPT FOR THE EXPRESS WARRANTIES SET FORTH IN THIS SECTION 7, IDEABLADE DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF TITLE, NON-INFRINGEMENT, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND ANY WARRANTIES ARISING OUT OF THE COURSE OF DEALING OR USAGE OF TRADE.
- 8. <u>Limitation of Liability</u>. IDEABLADE'S TOTAL LIABILITY TO YOU FROM ALL CAUSES OF ACTION AND UNDER ALL THEORIES OF LIABILITY WILL BE LIMITED TO THE AMOUNTS PAID OR OWING TO IDEABLADE BY YOU FOR THE SOFTWARE OR, IN THE EVENT THAT IDEABLADE HAS MADE THE SOFTWARE AVAILABLE TO YOU WITHOUT CHARGE, IDEABLADE'S TOTAL LIABILITY WILL BE LIMITED TO \$100. IN NO EVENT WILL IDEABLADE BE LIABLE TO YOU FOR ANY SPECIAL, INCIDENTAL, EXEMPLARY, PUNITIVE OR CONSEQUENTIAL DAMAGES (INCLUDING LOSS OF DATA, BUSINESS, PROFITS OR ABILITY TO EXECUTE) OR FOR THE COST OF PROCURING SUBSTITUTE PRODUCTS ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR THE EXECUTION OR PERFORMANCE OF THE SOFTWARE, WHETHER SUCH LIABILITY ARISES FROM ANY CLAIM BASED UPON CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE, AND WHETHER OR NOT IDEABLADE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS OR DAMAGE. THE FOREGOING LIMITATIONS WILL SURVIVE AND APPLY EVEN IF ANY LIMITED REMEDY SPECIFIED IN THIS AGREEMENT IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE. Some jurisdictions do not allow the limitation or exclusion of liability for incidental or consequential damages, so the above limitation or exclusion may not apply to you.
- 9. <u>Indemnity</u>. You agree to indemnify, hold harmless, and defend IdeaBlade and its resellers from and against any and all claims, lawsuits and proceedings (collectively "Claims"), and all expenses, costs (including attorney's fees), judgments, damages and other liabilities resulting from such Claims, that arise or result from the use or distribution of Your Integrated Product, as applicable.

- 10. Confidentiality. Except as otherwise provided herein, each party expressly undertakes to retain in confidence all information and know-how transmitted or disclosed to the other that the disclosing party has identified as being proprietary and/or confidential or that, by the nature of the circumstances surrounding the disclosure, ought in good faith to be treated as proprietary and/or confidential, and expressly undertakes to make no use of such information and know-how except under the terms and during the existence of this Agreement. However, neither party shall have an obligation to maintain the confidentiality of information that (i) it received rightfully from a third party without an obligation to maintain such information in confidence; (iii) the disclosing party has disclosed to a third party without any obligation to maintain such information in confidence; (iii) was known to the receiving party prior to its disclosure by the disclosing party; or (iv) is independently developed by the receiving party without use of the confidential information of the disclosing party. Further, either party may disclose confidential information of the other party as required by governmental or judicial order, provided such party gives the other party prompt written notice prior to such disclosure and complies with any protective order (or equivalent) imposed on such disclosure. Each party's obligations under this Section 10 shall apply at all times during the term of this Agreement and for two (2) years following termination of this Agreement.
- 11. <u>Export Law</u>. You agree to comply fully with all U.S. export laws and regulations to ensure that neither the Software nor any technical data related thereto nor any direct product thereof are exported or reexported directly or indirectly in violation of, or used for any purposes prohibited by, such laws and regulations.
- 12. General. This Agreement will be governed by and construed in accordance with the laws of the State of California, without regard to or application of conflict of laws rules or principles. The United Nations Convention on Contracts for the International Sale of Goods will not apply. You may not assign or transfer this Agreement or any rights granted hereunder, by operation of law or otherwise, without Company's prior written consent, and any attempt by you to do so, without such consent, will be void. Except as expressly set forth in this Agreement, the exercise by either party of any of its remedies under this Agreement will be without prejudice to its other remedies under this Agreement or otherwise. All notices or approvals required or permitted under this Agreement will be in writing and delivered by confirmed facsimile transmission, by overnight delivery service, or by certified mail, and in each instance will be deemed given upon receipt. All notices or approvals will be sent to the addresses set forth in the applicable ordering document or invoice or to such other address as may be specified by either party to the other in accordance with this section. The failure by either party to enforce any provision of this Agreement will not constitute a waiver of future enforcement of that or any other provision. Any waiver, modification or amendment of any provision of this Agreement will be effective only if in writing and signed by authorized representatives of both parties. If any provision of this Agreement is held to be unenforceable or invalid, that provision will be enforced to the maximum extent possible, and the other provisions will remain in full force and effect. This Agreement is the complete and exclusive understanding and agreement between the parties regarding its subject matter, and supersedes all proposals, understandings or communications between the parties, oral or written, regarding its subject matter, unless you and Company have executed a separate agreement. Any terms or conditions contained in your purchase order or other ordering document that are inconsistent with or in addition to the terms and conditions of this Agreement are hereby rejected by IdeaBlade and will be deemed null and void.
